## 1. What is this product?

<b>Type</b>	Dutch law governed warrants
<b>Term</b>	The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.
<b>Objectives</b> (Terms that appear in <b>bold</b> in this section are described in more detail in the table(s) below.)	<p>The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the <b>underlying</b>. The product has no fixed term. The product may terminate at any time as described below. If, upon termination of the product, the <b>underlying</b> has fallen to or below the <b>knock-out level</b>, the product will return less than your initial investment or even the minimum payment amount of EUR 0.001, which means you will effectively lose your initial investment.</p> <p><b>Leverage:</b> The product offers leveraged exposure to the performance of the <b>underlying</b>. 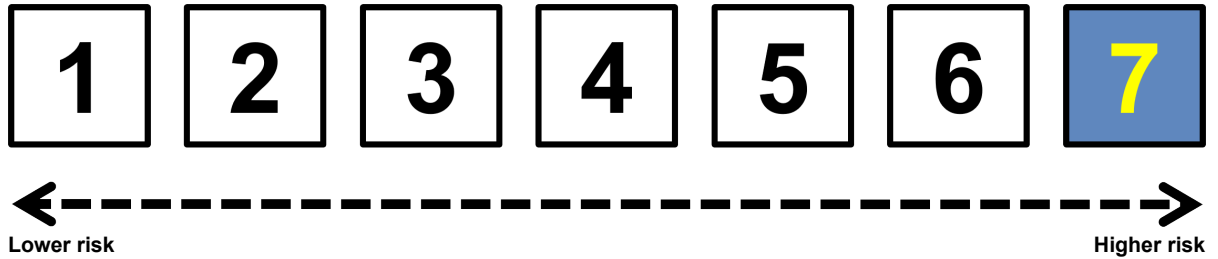
The product is intended to be offered to retail investors who fulfil all of the criteria below:

## 5. How long should I hold it and can I take money out early?

**Recommended holding period: 1 day**

The product reacts due to its leverage to small price movements of the underlying leading to potential profits or losses within unpredictable timeframes.

The product does not guarantee the possibility to disinvest other than by selling the product through the exchange. Save as otherwise disclosed in exit costs (see section "4.
