#### Purpose

## 1. What is this product?

Term	The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the <b>underlying</b> . The product is intended to be offered to retail investors who fulfil all of the criteria below:

### 2. What are the risks and what could I get in return?

## 5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day

Sudden changes in the value of the product can occur frequently, accordingly the recommended holding period is 1 day or less. The value of the product should be monitored constantly.
