The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the **underlying**. The product has no fixed term. The product may terminate at any time as described below. If, upon termination of the product, the **underlying** has fallen to or below the **knock-out level**, the product will return less than your initial investment or even the minimum payment amount of EUR 0.001, which means you will effectively lose your initial investment.

<u>Leverage</u>: The product offers leveraged exposure to the performance of the **underlying**. If the product has not automatically terminated early, you will in both cases on the **settlement date** receive a cash amount equal to (1) (A) the **reference price** on the **valuation date** minus (B) the **current financing level** on such date multiplied by (2) the **entitlement**, subject to a minimum of EUR 0.001.

Following the issuance of the product, the **knock-out level** and the **current financing level** will be adjusted for current market conditions and a fee. Updated information on the levels of such components will be available from the issuer and will be published on www.ingmarkets.de.

## 5. How long should I hold it and can I take money out early?

#### Recommended holding period: 1 day
