You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

Term	The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.
Objectives (Terms that appear in bold in this section are described in more detail in the table(s) below.)	The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying . The product has no fixed term. The product may terminate at any time as described below. If, upon termination of the product, the underlying has risen to or above the knock-out level , the product will return less than your initial investment or even the minimum payment amount of EUR 0.001, which means you will effectively lose your initial investment.
	Leverage: The product offers leveraged exposure to the performance of the underlying . 	If the product has not automatically terminated early, you will in both cases on the settlement date receive a cash amount equal to (1) (A) the current financing level on the valuation date minus (B) the reference level on such date multiplied by (2) the entitlement , and converted into EUR at the FX rate , subject to a minimum of EUR 0.001.

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

2. What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this product compared to other products. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact our capacity to pay you.

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day

Sudden changes in the value of the product can occur frequently, accordingly the recommended holding period is 1 day or less. The value of the product should be monitored constantly.

The product reacts due to its leverage to small price movements of the underlying leading to potential profits or losses within unpredictable timeframes. The product does not guarantee the possibility to disinvest other than by selling the product through the exchange. Save as otherwise disclosed in exit
