1. What is this product?

Term	The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying . The product has no fixed term. The product may terminate at any time as described below. If the product has not automatically terminated early, you will in both cases on the **settlement date** receive a cash amount equal to (1) (A) the **current financing level** on the **valuation date** minus (B) the **reference level** on such date multiplied by (2) the **entitlement**, and converted into EUR at the **FX rate**, subject to a minimum of EUR 0.001.

Following the issuance of the product, the **knock-out level** and the **current financing level** will be adjusted for current market conditions and a fee. Updated information on the levels of such components will be available from the issuer and will be published on www.ingmarkets.de.

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day
