1. What is this product?

| Objectives | <p>The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the <b>underlying</b>. ### Risk indicator

We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact our capacity to pay you.

## 3. What happens if ING Bank N.V. is unable to pay out?

## 5. How long should I hold it and can I take money out early?

**Recommended holding period: 1 day**

The product reacts due to its leverage to small price movements of the underlying leading to potential profits or losses within unpredictable timeframes.
