You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

Term	The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.
Objectives (Terms that appear in bold in this section are described in more detail in the table(s) below.)	The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying . The product has no fixed term. The product may terminate at any time as described below. 	Leverage: The product offers leveraged exposure to the performance of the underlying . Following the issuance of the product, the **knock-out level** and the **current financing level** will be adjusted for current market conditions and a fee. Updated information on the levels of such components will be available from the issuer and will be published on www.ingmarkets.de.

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

These events are specified in the product terms and principally relate to the **underlying**, the product and the issuer. 2. What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this product compared to other products. We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact our capacity to pay you.

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day

Sudden changes in the value of the product can occur frequently, accordingly the recommended holding period is 1 day or less. The value of the product should be monitored constantly.
