You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

The product has a fixed term and will be due on 28 June 2024.

The product is designed to provide a return in the form of a cash payment on the **settlement date** that will depend on the performance of the **underlying**. If, at maturity, the **final reference level** of the **underlying** has risen to or above 11,600, the product will return the minimum payment amount of EUR 0.001, which means you will effectively lose your initial investment.

<u>Leverage</u>: The product offers leveraged exposure to the performance of the **underlying**. This means that the payment you receive on the **settlement date** increases on a magnified basis as the performance of the **underlying** decreases, but you also bear a greater loss if the **underlying** performs positively.

Termination on the settlement date: On the settlement date you will receive:

- 1. if the **final reference level** is below 11,600, a cash payment equal to (i) the difference between (x) 11,600 and (y) the **final reference level**, multiplied by (ii) the **entitlement**; or
- if the final reference level is at or above 11,600, a cash payment equal to EUR 0.001, which means you will effectively lose your initial investment.

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the issuer may terminate the product early. These events are specified in the product terms and principally relate to the **underlying**, the product and the issuer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

2. What are the risks and what could I get in return?







The risk indicator assumes you keep the product for 1 month and 1 week. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact our capacity to pay you.
