You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

Term	The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.
Objectives (Terms that appear in bold in this section are described in more detail in the table(s) below.)	The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying . The product has no fixed term. The product may terminate at any time as described below. If, upon termination of the product, the underlying has fallen to or below the knock-out level , the product will return less than your initial investment or even the minimum payment amount of EUR 0.001, which means you will effectively lose your initial investment.
	Leverage: The product offers leveraged exposure to the performance of the underlying . 	If the product has not automatically terminated early, you will in both cases on the settlement date receive a cash amount equal to (1) (A) the reference price on the valuation date minus (B) the current financing level on such date multiplied by (2) the entitlement , and converted into EUR at the FX rate , subject to a minimum of EUR 0.001.
	Following the issuance of the product, the knock-out level and the current financing level will be adjusted for current market

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

These events are specified in the product terms and principally relate to the **underlying**, the product and the issuer. 

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day
