1. What is this product?

| Objectives | <p>The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying. 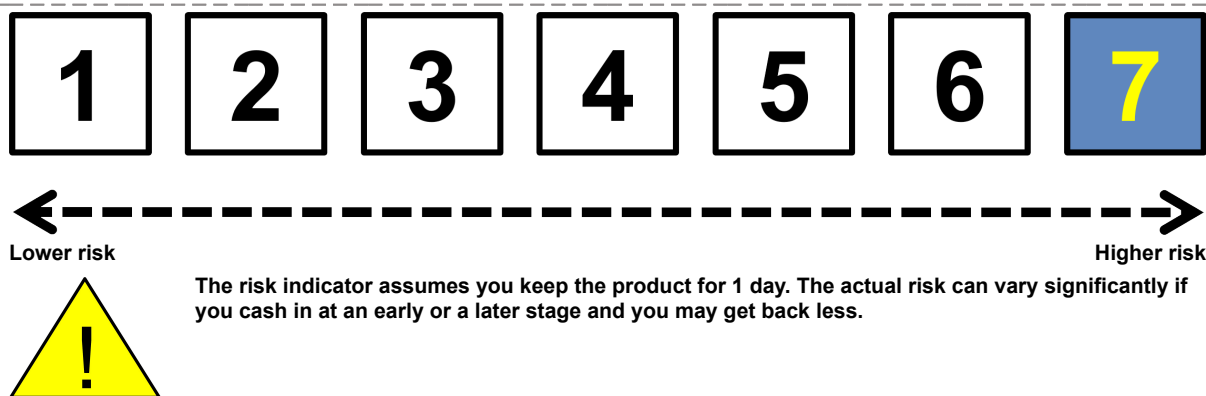
The product is intended to be offered to retail investors who fulfil all of the criteria below:

2. What are the risks and what could I get in return?

Risk indicator

We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact our capacity to pay you.

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day
