This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

Type	Dutch law governed equity-linked warrants / Return depends on the performance of the underlying / No capital protection against market risk
Term	The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.
Objectives	<p>The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying. The product has no fixed term. The product may terminate at any time as described below. If, upon termination of the product, the underlying has fallen to or below the knock-out level, the product will return less than your initial investment or even the minimum payment amount of EUR 0.001, which means you will effectively lose your initial investment.</p> <p><u>Leverage</u>: The product offers leveraged exposure to the performance of the underlying. This means that the payment you receive following exercise by you or termination by us increases on a magnified basis as the performance of the underlying increases, but you also bear a greater loss if the underlying performs negatively.</p> <p><u>Automatic early termination</u>: If the price of the underlying at any time during the term of the product is at or below the barrier price, the product will terminate immediately and you will receive EUR 0.001, which means you will effectively lose your initial investment.</p> <p><u>Exercise by you or termination by us</u>: You may exercise the product on certain dates and subject to the notice periods set out in the product terms (see "7. We may also terminate the product on certain dates and subject to the notice periods set out in the product terms. The exercise or termination, as the case may be, will be effective after the period of time indicated in the product terms.</p> <p>If the product has not automatically terminated early, you will in both cases on the settlement date receive a cash amount equal to (1) (A) the reference price on the valuation date minus (B) the current financing level on such date multiplied by (2) the entitlement, subject to a minimum of EUR 0.001.</p> <p>Following the issuance of the product, the knock-out level and the current financing level will be adjusted for current market conditions and a fee. The product is intended to be offered to retail investors who fulfil all of the criteria below:

- 1. they have advanced knowledge and a comprehensive understanding of the product, its market and its specific risks and rewards, with relevant financial industry experience including either frequent trading or large holdings in products of a similar nature, risk and complexity, either independently or through professional advice;
- 2. they seek hedging and/or disproportionate participation in the performance of the underlying, expect the movement in the underlying to perform in a way that generates a positive return. They have a very short investment horizon and understand that the product may terminate early;
- 3. they are able to bear a total loss of their initial investment, consistent with the redemption profile of the product at maturity (market risk);
- 4. they accept the risk that the issuer could fail to pay or perform its obligations under the product irrespective of the redemption profile of the product (credit risk);
- 5. they are willing to accept a level of risk of 7 out of 7 to achieve potential returns, which reflects the highest risk (as shown in the summary risk indicator below which takes into account both market risk and credit risk).

2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 1 day. The actual risk can vary significantly if you cash in at an early or a later stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact our capacity to pay you. This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment. The favourable, moderate, unfavourable and stress scenarios represent possible outcomes that have been calculated based on simulations using the past performance of the underlying over a period of up to 5 years. The stress scenario shows what you might get back in extreme market circumstances. 3. What happens if ING Bank N.V. is unable to pay out?

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day

Sudden changes in the value of the product can occur frequently, accordingly the recommended holding period is 1 day or less. The value of the product should be monitored constantly.

The product reacts due to its leverage to small price movements of the underlying leading to potential profits or losses within unpredictable timeframes.

The product does not guarantee the possibility to disinvest other than by selling the product through the exchange. Save as otherwise disclosed in exit costs (see section "4. What are the costs?" above), no fees or penalties will be charged by the issuer for any such transaction, however an execution fee might be chargeable by your broker if applicable.
