1. What is this product?

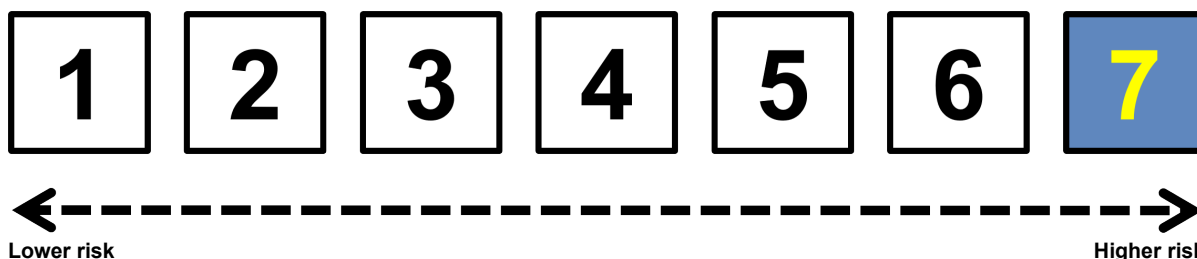
Type	Dutch law governed warrants
Term	The product has a fixed term and will be due on 27 December 2024.
Objectives	<p>The product is designed to provide a return in the form of a cash payment on the settlement date that will depend on the performance of the underlying. If, at maturity, the final reference price of the underlying has fallen to or below EUR 110, the product will return the minimum payment amount of EUR 0.001, which means you will effectively lose your initial investment.</p> <p>Leverage: The product offers leveraged exposure to the performance of the underlying. These events are specified in the product terms and principally relate to the underlying, the product and the issuer. 2. What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 7 months. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact our capacity to pay you.

Inflation erodes the purchasing value of cash over time and this may result in the decline in real terms of any capital reimbursed.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

5. How long should I hold it and can I take money out early?

Recommended holding period: 7 months
