1. What is this product?

Term	The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.

The product has no fixed term. The product may terminate at any time as described below. 2. What are the risks and what could I get in return?

Risk indicator

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day
