<u>Leverage</u>: The product offers leveraged exposure to the performance of the **underlying**. This means that the payment you receive following exercise by you or termination by us increases on a magnified basis as the performance of the **underlying** increases, but you also bear a greater loss if the **underlying** performs negatively.

Automatic early termination: If the level of the **underlying** at any time during the term of the product is at or below the **barrier level**, the product will terminate immediately, you will receive no payment and you will lose your initial investment.

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day

Sudden changes in the value of the product can occur frequently, accordingly the recommended holding period is 1 day or less. The value of the product should be monitored constantly.

The product does not guarantee the possibility to disinvest other than by selling the product through the exchange. Save as otherwise disclosed in exit costs (see section "4.
