You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the **underlying**. The product has no fixed term. The product may terminate at any time as described below. If, upon termination of the product, the **underlying** has fallen to or below the **knock-out level**, the product will return less than your initial investment or even zero.

<u>Leverage</u>: The product offers leveraged exposure to the performance of the **underlying**. Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.
