This means that the payment you receive following exercise by you or termination by us increases on a magnified basis as the performance of the **underlying** decreases, but you also bear a greater loss if the **underlying** performs positively.

Automatic early termination: If the level of the **underlying** at any time during the term of the product is at or above the **barrier level**, the product will terminate immediately, you will receive no payment and you will lose your initial investment.

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day

Sudden changes in the value of the product can occur frequently, accordingly the recommended holding period is 1 day or less. The value of the product should be monitored constantly.
