1. What is this product?

Objectives	<p>The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the <b>underlying</b>. ### Risk indicator



The risk indicator assumes you keep the product for 1 day. The actual risk can vary significantly if you cash in at an early or a later stage and you may get back less.

## 5. How long should I hold it and can I take money out early?

**Recommended holding period: 1 day**
