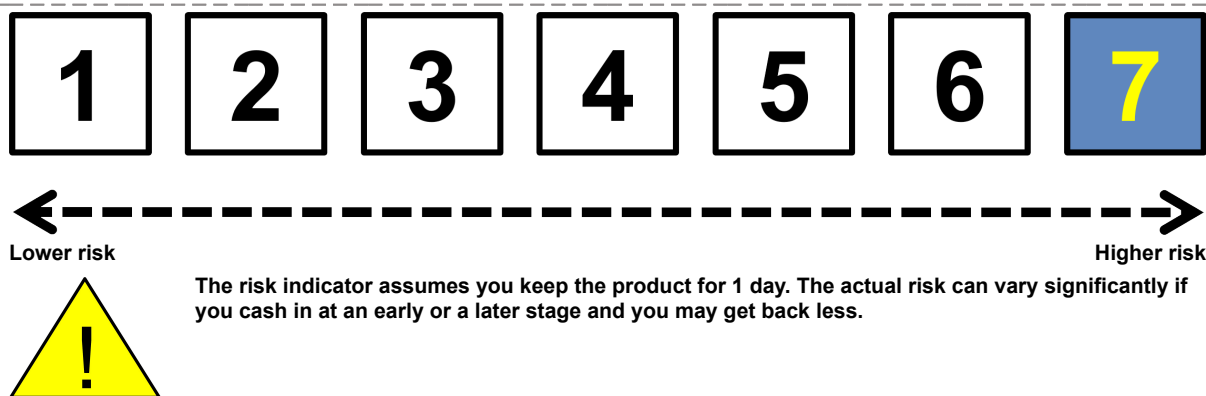
The product is intended to be offered to retail investors who fulfil all of the criteria below:

Risk indicator

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day
