The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the **underlying**. The product has no fixed term. The product may terminate at any time as described below. If, upon termination of the product, the **underlying** has fallen to or below the **knock-out level**, the product will return less than your initial investment or even zero.

<u>Leverage</u>: The product offers leveraged exposure to the performance of the **underlying**. This means that the payment you receive following exercise by you or termination by us increases on a magnified basis as the performance of the **underlying** increases, but you also bear a greater loss if the **underlying** performs negatively.

<u>Automatic early termination</u>: If the level of the **underlying** at any time during the term of the product is at or below the **barrier level**, the product will terminate immediately, you will receive no payment and you will lose your initial investment.

If the product has not automatically terminated early, you will in both cases on the **settlement date** receive a cash amount equal to (1) (A) the **reference level** on the **valuation date** minus (B) the **current financing level** on such date divided by (2) the **ratio**, subject to a minimum of EUR 0.00.

Following the issuance of the product, the **knock-out level** and the **current financing level** will be adjusted for current market conditions and a fee. Updated information on the levels of such components will be available from the issuer and will be published on www.ingsprinters.nl.

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

These events are specified in the product terms and principally relate to the **underlying**, the product and the issuer. The risk indicator assumes you keep the product for 1 day. The actual risk can vary significantly if you cash in at an early or a later stage and you may get back less.

We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact our capacity to pay you.

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day
