Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. 3. What happens if ING Bank N.V. is unable to pay out?

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day

Sudden changes in the value of the product can occur frequently, accordingly the recommended holding period is 1 day or less. The value of the product should be monitored constantly.
