## 1. What is this product?

The product has no fixed term. The product may terminate at any time as described below. 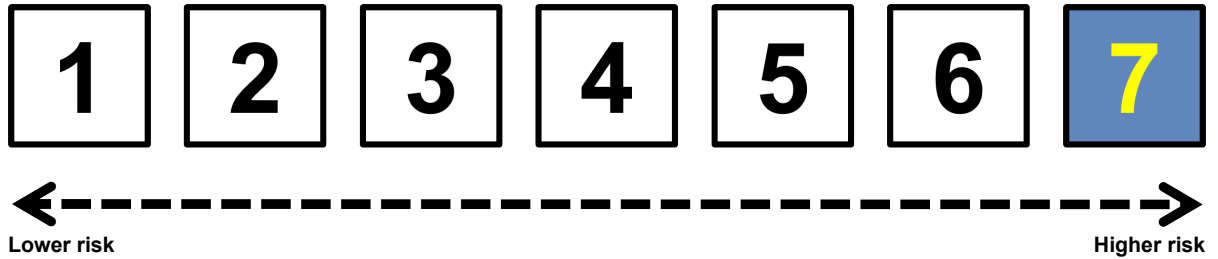
The product is intended to be offered to retail investors who fulfil all of the criteria below:

### 5. How long should I hold it and can I take money out early?

**Recommended holding period: 1 day**
