#### Purpose

#### 1. What is this product?

Term	The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.

The exercise or termination, as the case may be, will be effective after the period of time indicated in the product terms.

If the product has not automatically terminated early, you will in both cases on the **settlement date** receive a cash amount equal to (1) (A) the **current financing level** on the **valuation date** minus (B) the **reference level** on such date divided by (2) the **ratio**, subject to a minimum of JPY 0.00, and converted into EUR at the **FX rate**.

The risk indicator assumes you keep the product for 1 day. The actual risk can vary significantly if you cash in at an early or a later stage and you may get back less.

### 5. How long should I hold it and can I take money out early?

#### Recommended holding period: 1 day

Sudden changes in the value of the product can occur frequently, accordingly the recommended holding period is 1 day or less. The value of the product should be monitored constantly.

The product reacts due to its leverage to small price movements of the underlying leading to potential profits or losses within unpredictable timeframes.
