1. What is this product?

The product has no fixed term. The product may terminate at any time as described below. ## 2. What are the risks and what could I get in return?

### Risk indicator

## 3. What happens if ING Bank N.V. is unable to pay out?

#### 5. How long should I hold it and can I take money out early?

**Recommended holding period: 1 day**

**Sudden changes in the value of the product can occur frequently, accordingly the recommended holding period is 1 day or less. The value of the product should be monitored constantly.**

The product reacts due to its leverage to small price movements of the underlying leading to potential profits or losses within unpredictable timeframes.
