<u>Automatic early termination</u>: If the level of the **underlying** at any time during the term of the product is at or above the **knock-out level**, the product will terminate immediately and you will receive a cash amount equal to (A) (1) the **current financing level** minus (2) a level for the **underlying** based on the levels at which we are able to unwind our hedging positions immediately following any such event, divided by (B) the **ratio**, subject to a minimum of USD 0.00, and converted into EUR at the **FX rate**.

Exercise by you or termination by us: You may exercise the product on certain dates and subject to the notice periods set out in the product terms (see "7. Other Relevant Information" below for more information on where you can obtain the product terms). We may also terminate the product on certain dates and subject to the notice periods set out in the product terms. The exercise or termination, as the case may be, will be effective after the period of time indicated in the product terms.

If the product has not automatically terminated early, you will in both cases on the **settlement date** receive a cash amount equal to (1) (A) the **current financing level** on the **valuation date** minus (B) the **reference level** on such date divided by (2) the **ratio**, subject to a minimum of USD 0.00, and converted into EUR at the **FX rate**.

Following the issuance of the product, the **knock-out level** and the **current financing level** will be adjusted for current market conditions and a fee. Updated information on the levels of such components will be available from the issuer and will be published on www.ingsprinters.nl.

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.



Higher risk

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day

Sudden changes in the value of the product can occur frequently, accordingly the recommended holding period is 1 day or less. The value of the product should be monitored constantly.
