You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

Type	Dutch law governed warrants
Term	The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.
Objectives	<p>The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the <b>underlying</b>. The product has no fixed term. The product may terminate at any time as described below. If, upon termination of the product, the <b>underlying</b> has risen to or above the <b>knock-out level</b>, the product will return less than your initial investment or even zero.</p> <p><u>Leverage</u>: The product offers leveraged exposure to the performance of the <b>underlying</b>. The risk indicator assumes you keep the product for 1 day. The actual risk can vary significantly if you cash in at an early or a later stage and you may get back less.

We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact our capacity to pay you.

## 3. What happens if ING Bank N.V. is unable to pay out?

#### 5. How long should I hold it and can I take money out early?

**Recommended holding period: 1 day**

**Sudden changes in the value of the product can occur frequently, accordingly the recommended holding period is 1 day or less. The value of the product should be monitored constantly.**

The product reacts due to its leverage to small price movements of the underlying leading to potential profits or losses within unpredictable timeframes.
