The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the **underlying**. The product has no fixed term. The product may terminate at any time as described below. The exercise or termination, as the case may be, will be effective after the period of time indicated in the product terms.

If the product has not automatically terminated early, you will in both cases on the **settlement date** receive a cash amount equal to (1) (A) the **reference price** on the **valuation date** minus (B) the **current financing level** on such date divided by (2) the **ratio**, subject to a minimum of USD 0.00, and converted into EUR at the **FX rate**.

#### Recommended holding period: 1 day
