You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

Term	The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying . 5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day
