## 1. What is this product?

The product has no fixed term. The product may terminate at any time as described below. ### Risk indicator

#### 5. How long should I hold it and can I take money out early?

**Recommended holding period: 1 day**

The product reacts due to its leverage to small price movements of the underlying leading to potential profits or losses within unpredictable timeframes.
