The exercise or termination, as the case may be, will be effective after the period of time indicated in the product terms.

If the product has not automatically terminated early, you will in both cases on the **settlement date** receive a cash amount equal to (1) (A) the **reference price** on the **valuation date** minus (B) the **current financing level** on such date divided by (2) the **ratio**, subject to a minimum of USD 0.00, and converted into PLN at the **FX rate**.

Following the issuance of the product, the **knock-out level** and the **current financing level** will be adjusted for current market conditions and a fee. Updated information on the levels of such components will be available from the issuer and will be published on www.ingturbo.pl.

## 5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day
