1. What is this product?

The product has no fixed term. The product may terminate at any time as described below. If, upon termination of the product, the underlying has fallen to or below the knock-out level, the product will return less than your initial investment or even zero.</p> <p>Leverage: The product offers leveraged exposure to the performance of the underlying. 2. What are the risks and what could I get in return?

Risk indicator

We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact our capacity to pay you.

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day

Sudden changes in the value of the product can occur frequently, accordingly the recommended holding period is 1 day or less. The value of the product should be monitored constantly.
