## 1. What is this product?

<b>Term</b>	The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.

The product has no fixed term. The product may terminate at any time as described below. If, upon termination of the product, the <b>underlying</b> has risen to or above the <b>knock-out level</b>, the product will return less than your initial investment or even zero.</p> <p><b>Leverage:</b> The product offers leveraged exposure to the performance of the <b>underlying</b>. **Intended retail investor**

The product is intended to be offered to retail investors who fulfil all of the criteria below:

1. they have advanced knowledge and a comprehensive understanding of the product, its market and its specific risks and rewards, with relevant financial industry experience including either frequent trading or large holdings in products of a similar nature, risk and complexity, either independently or through professional advice;
2. they seek hedging and/or leveraged performance, expect the movement in the underlying to perform in a way that generates a favourable return, have an investment horizon of the recommended holding period specified below and understand that the product may terminate early;

**2. What are the risks and what could I get in return?**

**Risk indicator**



**The risk indicator assumes you keep the product for 1 day. The actual risk can vary significantly if you cash in at an early or a later stage and you may get back less.**

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact our capacity to pay you.

**Be aware of currency risk:** If the currency of your account is different to the currency of this product, you will be exposed to the risk of suffering a loss as a result of the conversion of the currency of the product into the account currency. This risk is not considered in the indicator shown above. Because the product currency is different from the underlying currency, you will be exposed to the risk of suffering a loss if the underlying currency declines in value relative to the product currency.

**Be aware of currency risk:** If (i) the Underlying is traded in a different currency than EUR the unwind amount will be converted to EUR at the prevailing exchange rate which may result in a loss; or (ii) the currency of your account is different from the Currency of the product, you may be exposed to the risk of suffering a loss as a result of the conversion of the Currency of the product into the account currency. ### 3. What happens if ING Bank N.V. is unable to pay out?

### 5. How long should I hold it and can I take money out early?

**Recommended holding period: 1 day**

The product reacts due to its leverage to small price movements of the underlying leading to potential profits or losses within unpredictable timeframes.
